



# 2010-2011 Vigil Honor Nomination Form

Deadline for submission: Must be received at  
Catalina Council Office by May 27, 2011.

The Vigil Honor is the highest honor that a Lodge can bestow upon a member. It dates back to 1915 when our Founder, Dr. E. Urner Goodman became the first Vigil Honor Member. It is a mark of high distinction and is reserved for those arrowmen who have given exceptional service and who help others above and beyond the call of duty. The Vigil Honor requires unselfish dedication to one or more of the following: the Lodge, the Order of the Arrow, Scouting, or the Council Camps. The Vigil Honor is recognition of one's commitment to altruistic leadership and proper example of Brotherhood in Cheerful Service. Alertness to the needs of others is the mark of the Vigil Honor.

Nominations for the Vigil Honor ought to be taken seriously. Please provide as much information about the nominee as possible. In this way the Vigil Honor & Founders' Award Selection Committee can make a fair assessment of the contributions of the nominee to Scouting, the Lodge, and his community.

To be eligible for the Vigil Honor an arrowman must:

1. Be a Brotherhood member for the last two years (Brotherhood ceremony before May 27th, 2009).
2. Be registered in the Catalina Council, BSA.
3. Be a member in good standing of Papago Lodge, 494. (Dues paid for 2011).

In order for a nomination to be accepted it must:

1. Be submitted on an official and current Vigil Honor Nomination form. Any additional information can be attached to the nomination form.
2. **DEADLINE FOR SUBMISSION: Received by a member of the L.E.C. or at the Catalina Council Office no later than May 27th, 2011.**
