The Founders' Award was created in 1981 by the National Order of the Arrow Committee to honor and recognize those Arrowmen who have given outstanding service to the Lodge. The award is reserved for a member who demonstrates to their fellow Arrowmen that they memorialize in their everyday life, the spirit of achievement as described by the Order's founders Dr. E. Urner Goodman and Carroll A. Edson. The Founders' Award is used to recognize those Arrowmen, youth and adult, who have impacted the Lodge in a positive and lasting way. This is a rare and distinguished honor presented to recognize the spirit of our Founders visible in worthy Arrowmen.

Nominations for the Founders' Award ought to be taken seriously. Please provide as much information about the nominee as possible. In this way the Vigil Honor & Founders Award Selection Committee can make a fair assessment of the contributions of the nominee to the Lodge.

To be eligible for the Founders' Award an arrowman must:

1. Be registered in the Catalina Council, BSA.
2. Be a member in good standing of Papago Lodge, 494. (Dues paid for 2007).

In order for a nomination to be accepted it must:

1. Be submitted on an official and current Founders' Award Nomination form. Any additional information can be attached to the nomination form.
2. **DEADLINE FOR SUBMISSION: Received by a member of the L.E.C. or at the Catalina Council Office no later than May 16<sup>th</sup>, 2007.**
